Welcome to the International Sidereal Astrology Association (ISAA). By enrolling your organization as an Institutional Member, you agree to the following membership terms, benefits, and conditions.

1. Membership Terms

The following terms outline the duration and renewal conditions of your Institutional Membership:

A. Annual Membership Option

- 1) Membership Duration: One Year
- 2) Membership Dues: \$300/year
- 1) Renewal: Membership must be renewed annually. Prices and benefits are subject to change.
