# Website Privacy Policy

### 1. Introduction

# 3. How We Use Your Information

We use your information to:

- 2) Process transactions and send confirmations;
- 3) Respond to inquiries and provide customer support;
- 4) Offer discounts and member benefits;
- 5) Send newsletters and promotional emails (with opt-out options);
- 6) Improve website functionality and user experience;
- 7) Detect and prevent fraud or security breaches;

8) Comply with legal obligations.

### 4. How We Share Your Information

We do not sell or rent your personal data. We do not sell, rent, share, or disclose your personal information, including phone numbers, to third parties or affiliates for marketing or lead generation purposes. However, we may share information in the following cases:

- 1) Service Providers: We may share data with third-party vendors who assist with payment processing, email communication, and website maintenance;
- 2) Legal Requirements: We may disclose personal information when required by law or to protect our rights and security;
- 3) Membership Directory: If you are a Professional, Institutional, or Founding Member, your name and website (if provided) will be listed in our online directory;
- 4) Consent-Based Sharing: We may share information with your consent.

### 5. Data Retention

We retain your personal information for as long as necessary to fulfill the purposes outlined in this policy, comply with legal obligations, or resolve disputes. You may request deletion of your data at any time by contacting us.

# 6. Cookies and Tracking Technology

We use cookies and similar tracking technologies to enhance your experience on our website. Cookies help us:

- 1) Recognize returning visitors;
- 2) Understand site traffic and usage patterns;
- 3) Improve website functionality;
- 4) Provide targeted content and advertisements.

You can adjust your browser settings to refuse cookies, but some site features may not function properly without them.

## 7. Security Measures

We take reasonable security measures to protect your information from unauthorized access, disclosure, or misuse. Our website utilizes Secure Socket Layer (SSL) encryption to safeguard data transmission, ensuring that any personal or payment information you provide remains encrypted and secure. Additionally, we implement Wordfence security software, which provides advanced protection against cyber threats, malware, and unauthorized access attempts.

However, no method of transmission over the Internet is 100% secure. We encourage users to protect their login credentials and notify us of any suspicious activity.

# 9. Your Rights and Choices
